



PRO FLEET REBATE PROGRAM

(NOTE: Replaces All Previous Programs)

Requirements to qualify for Pro Fleet Rebate:

1. Pro Fleet assistance is eligible for reimbursement to the selling dealer only if the sale is in the county or adjoining counties of the selling dealer (unless otherwise agreed upon in advance in writing from the VP of Sales).
2. Proof of sale to a business entity must be provided. (Ex.: CC of tax return, business card, business certificate, blank invoice, etc.)
3. Fleet sales are to one customer, on one single transaction.
4. Minimum quantity to qualify for Pro Fleet Rebate is 8 points on the chart below.
5. Approved sales utilizing the Pro Fleet Program are eligible for add-on sales within 360 days of the original fleet sale.
6. Add-on sales that occur within 12-months of original sale, that bring the total number of units purchased to next rebate bracket will be credited accordingly.

1. A signed dealer invoice evidencing delivery to the buyer, including serial numbers of units delivered, must accompany the dealer claim.
2. Rebate will **only** be issued with the submission of valid **mail-to** and **email address** of buyer.
3. Proof of warranty registration from dealer portal.
4. Dealer submits a Pro Fleet Rebate Request Form that has been filled in **completely and accurately**. Serial Numbers must be shown for all serialized units.
5. Claims must be received complete with all required information within 60 days of the date of sale to an eligible customer.
6. This offer **CANNOT** be used in conjunction with any other company sponsored rebate program.
